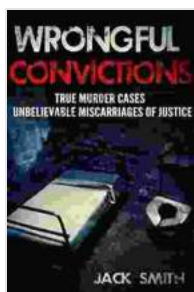

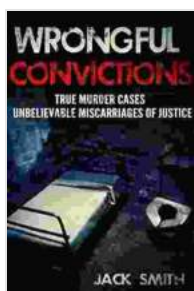
#### **6. The Cheshire Murders**
